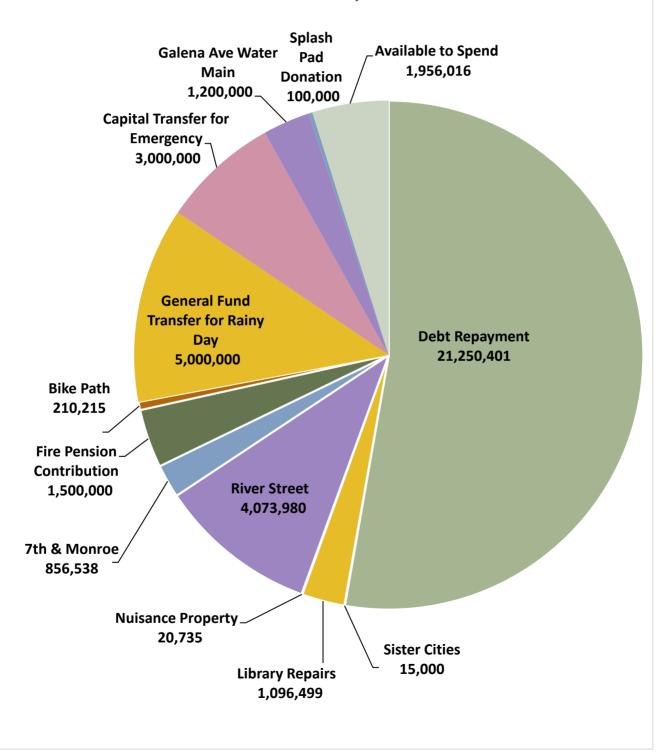

# ORDINANCE AMENDING TITLE 4, CHAPTER 8 OF THE DIXON CITY CODE (EMERGENCY VEHICLE AMBULANCE SERVICE CHARGES)

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and the City Council of the City of Dixon, Illinois, as follows:

SECTION 1: That Title 4, Chapter 8 of the Dixon City Code, as amended, shall be further amended by amending Section 4-8-1 to read as follows:

#### "4-8-1: CHARGES FOR EMERGENCY VEHICLE AMBULANCE SERVICES:

- (A) The City shall bill Medicare, Medicaid or insurance, as applicable, the charges set forth below for emergency vehicle ambulance services provided to any resident or nonresident of the City. The City shall write off any portion of a resident's bill that is not paid by Medicare, Medicaid or insurance. Nonresidents shall be required to pay the City any portion of the bill that is not paid by Medicare, Medicaid or insurance.
  - 1. One thousand dollars (\$1000.00) for basic life support; plus
  - 2. Twenty-five dollars (\$25.00) per loaded mile for each mile the ambulance travels; plus
  - 3. One thousand dollars (\$1000.00) for advance life support 1; or
  - 4. One thousand dollars (\$1000.00) for advance life support 2. "Advance life support 2" shall mean a situation which requires administration of three (3) medications administered, or defibrillation or intubation; plus
  - 5. Thirty-five dollars (\$35.00) for oxygen.
- (B) For advance life support intercepts, the City shall charge the requesting agency a fee of two hundred dollars (\$200.00)."

SECTION 2: That Title 4, Chapter 8 of the Dixon City Code, as amended, shall be further amended by amending Section 4-8-3 to read as follows:

#### "4-8-3: PAYMENT OF CHARGES:

(A) All bills for emergency vehicle ambulance service charges shall be paid on or before the due date as noted on the bill. Bills and notices shall be mailed or delivered to the patient's last known address, but the failure to receive a bill will not relieve the patient from the obligation to pay the bill. Unpaid bills become delinquent thirty (30) days after the due date noted thereon.

- (B) The Dixon Fire Department shall adjust the charge for emergency vehicle ambulance services to the current Medicaid rate if the patient and/or any other person legally obligated to pay provides the Dixon Fire Department with reliable information that:
  - 1. The patient and/or any other persons legally obligated to pay has insufficient annual income to pay the bill without undue hardship. The Dixon Fire Department shall define "insufficient annual income" from time to time; provided, that it shall in no event be defined as being more than 300% of the then-current Federal Poverty Level as set forth in the Federal Register; and
  - 2. The patient is not covered by any insurance that would pay for the services and cannot obtain Medicare or Medicaid.
- (C) The Dixon Fire Department has the sole authority to determine whether the information provided supports an adjustment of the charge."

SECTION 3: In all other respects, Title 4, Chapter 8 shall remain in full force and effect.

SECTION 4: The provisions and sections of this Ordinance shall be deemed to be separable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

SECTION 5: All ordinances and parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION 6: The City Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 7: This Ordinance shall be in full force and effect from and after its passage and approval, and publication as required by law.

WHEREAS, this Ordinance is adopted pursuant to the provisions of the Illinois Municipal Cannabis Retailers' Occupation Tax Law, 65 ILCS 5/11-8-22 *et seq.* (the "Act"); and

WHEREAS, this Ordinance is intended to impose the tax authorized by the Act providing for a municipal cannabis retailers' occupation tax which will be collected by the Illinois Department of Revenue.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Dixon as follows:

SECTION 1: The City hereby finds that all of the recitals contained in the preambles to this Ordinance are true and correct and does incorporate them into this Ordinance by this reference.

SECTION 2: That Title 5 of the Dixon City Code, as amended, is hereby further amended by adding a new Chapter 24 entitled "Municipal Cannabis Retailers' Occupation Tax" to read as follows:

# "Chapter 24 MUNICIPAL CANNABIS RETAILERS' OCCUPATION TAX

5-24-1: TAX IMPOSED; RATE

5-24-2: COLLECTION OF TAX BY RETAILERS

#### 5-24-1: TAX IMPOSED; RATE:

- (a) A tax is hereby imposed upon all persons engaged in the business of selling cannabis, other than cannabis purchased under the Compassionate Use of Medical Cannabis Pilot Program Act, at retail in the City at the rate of three percent (3%) of the gross receipts of these sales made in the course of that business. The tax imposed hereunder be paid in addition to any and all other taxes and charges.
- (b) The imposition of this tax is in accordance with the provisions of Section 8-11-22 of the Illinois Municipal Code, 65 ILCS 5/8-11-22.

#### 5-24-2: COLLECTION OF TAX BY RETAILERS:

(a) The tax imposed by this Chapter shall be remitted by such retailer to the Illinois Department of Revenue (the "Department"). Any tax required to be collected

pursuant to or as authorized by this Chapter and any such tax collected by such retailer and required to be remitted to the Department shall constitute a debt owed by the retailer to the State of Illinois. Retailers may reimburse themselves for their seller's tax liability hereunder by separately stating that tax as an additional charge, which charge may be stated in combination, in a single amount, with any State of Illinois tax that sellers are required to collect.

- (b) The taxes hereby imposed, and all civil penalties that may be assessed as an incident thereto, shall be collected and enforced by the Department. The Department shall have full power to administer and enforce the provisions of this Chapter."
- SECTION 3: In all other respects, Title 5 of the Dixon City Code, as amended, shall remain in full force and effect.
- SECTION 4: The provisions and sections of this Ordinance shall be deemed to be separable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.
- SECTION 5: All ordinances and parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
- SECTION 6: The City Clerk is hereby directed to publish this Ordinance in pamphlet form.
- SECTION 7: This Ordinance shall be in full force and effect from and after its passage and approval, and publication as required by law; provided, however, that the tax provided for herein shall take effect for all sales on or after the first day of January, 2020. A certified copy of this Ordinance shall be sent to the Illinois Department of Revenue prior to September 30, 2019.
