I'm forwarding the new design that would be 20'x35'. I believe the left side of the wall would be the best placement, although it could be painted on the right side of the wall as well.

My price to do a 700 square foot mural at \$25 sq. ft comes out to \$17,500. This includes materials, labor and any scaffolding I have to rent.
