## Jack Schrauth

Recommendation: Council - Manager Form assuming that it is an overlay on the Commission Form of government

Comment: Commission Form of Government offers a two-week "place on file" safeguard where the public can view ordinances, resolutions, and contracts before being approved. Is this an option under the Council-Manager form of government?

#### Jim Marshall

Recommendation: Commissioner with City Administrator

Comment: I'm concerned that the current plan to bring an "intern administrator" will slow down the progress that we are making, especially if our recommendation is to change our current form of government. It's 20 months of waiting to see what happens

### Marilyn Coffey

Recommendation: Council-Manager Form

Comment: Disagree with Jim in regards to the City Administrator slowing down progress within the city. I fully support Council-Manager form of government. I look at the job description that Danny has created and think "why do we need Commissioners (the position)?"

I think that the citizens deserve a vote. What greater choice than to let the citizens choose which form of government they would like to represent the community.

I feel we are getting bogged down in the legality of the form.

Recommendation: Council-Manager is the way to go.

Recommendation: Council-Manager Form

Comment: The position of council member under the Council-Manager form of government seems to be less time-demanding than the Commission form. This will hopefully bring new blood to the council.

### Tom Shaw

Recommendation: Council-Manager Form

Comment: The best scenario is to retain the good things that the Commission form brings with the stability of the Council-Manager form.

<u>Discussion by GTF</u> regarding what the form of government would look like with the Council-Manager form overlaying the Commission form.

All agree that the professional hired should be given the power through state statute rather than by ordinance. However, there are questions about what is retained through the law with the Commission form of government and what is changed.

Q: How will the ballot proposition read?

All agreed that abandoning the Commission form of government is not an option. If the recommended government on the ballot were not to be approved, the city would default to their form that was active before the Commission form.

Rob would rather see Council-Manager overlay over Commission Form of Government.
