## **ROLL CALL**

The meeting was called to order by Mayor Burke. Commissioners Considine, Kuhn, Blackburn, Brechon and Mayor Burke answered Roll Call. Rev. Dr. Vinnie Marrandino, Chaplain of KSB Hospital gave the Invocation.

#### **APPROVAL OF MINUTES**

Commissioner Considine moved that the minutes of the Regular Council Meeting of Monday, November 18, 2013 be accepted and placed on file. Voting Yea: Commissioners Considine, Kuhn, Blackburn, Brechon and Mayor Burke. Voting Nay: None. Motion carried.

## APPROVAL OF TOTAL LABOR & OUTSIDE CLAIMS

#### **COUNCIL REPORTS**

Mayor Burke advised that Dan Langloss has followed up on the speaker system for the Council Chambers. Mayor Burke stated the people who will be installing the system would be at City Hall tomorrow to measure. He then stated the installing would hopefully be done in January.

Commissioner Considine advised this is the 20<sup>th</sup> year of the "Keep the Wreath Red" program sponsored by Dixon Rural and Dixon Fire Departments. He stated this program will run from December 3, 2013 through January 6, 2014 and the wreath will only be changed to white if there is a major fire. Commissioner Considine then stated for everyone to have a safe holiday season.

Commissioner Kuhn reminded the citizens that snow time is approaching and the odd/even parking will be in place after 3 inches of snow has fallen.

Commissioner Blackburn advised that Item #13-A on the agenda tonight is to vote on a Resolution to pay off the debt early from the 2008, 2010 and 2011 bonds.

# AUTHORIZE EXECUTION OF AGREEMENT FOR PRELIMINARY ENGINEERING SERVICES – STREETSCAPE PROJECT WENDLER ENGINEERING/WILLETT HOFMANN & ASSOCIATES

Commissioner Kuhn moved that the Mayor be authorized to execute the 2014 Downtown Dixon Streetscape Agreement for Preliminary Engineering Services between the City of Dixon and Wendler Engineering and Willett Hofmann & Associates. Discussion followed. Mayor Burke talked about a wiring system to be possibly installed for music year round. Commissioner Brechon advised she visited LeClaire, Iowa's downtown and they have the music as well as information kiosks. Scott Brown, Wendler Engineering, advised the preliminary engineering work has started. He then advised that after the holidays, an evening meeting would be scheduled for the public. Commissioner Kuhn asked about the water and sewer, and Dan Mahan, Wastewater Superintendent, advised the sewer line in this area needs to be televised and cleaned prior to the start of this project.
