12. Unfinished Business

A. Authorize Mayor to Execute Hot-Mix Asphalt Maintenance Contract

This contract was awarded to Universal Asphalt & Excavating, Inc., LaSalle, Illinois to do the hot-mix asphalt street maintenance of various City streets, using both Motor Fuel and local funds.

B. Ord. – Establishing Prevailing Wages

An ordinance to regulate wages of all Public Works employees in the State which must be passed prior to July 1<sup>st</sup> of each year.

C. Award Bid – 2014/2015 Gasoline & Oil

North Oil Company, Dixon, Illinois, was the sole bidder and their pricing is acceptable.

C. Authorize Mayor to Execute Lease Agreement – City/Dixon Sister Cities Association

This one-year lease is to allow Dixon Sister Cities the use of the basement level conference room at City Hall.

D. Authorize to Advertise for Bids – River Street Sewer Replacement – Crawford Avenue to Ravine Avenue & Alternate Bid #1 – Raynor Lift Station Replacement

City will advertise for bids for this project with the base bid being for the trunk sewer and the alternate bid for the Lift Station replacement. It would all be bid under one contract with the priority of awarding the sewer replacement first and, if the additional cost comes in within the total budget, then the lift station replacement project would be done.
