A. Award Bid – River Street Trunk Sewer Replacement – Crawford Avenue to Ravine Avenue

&

Alternate Bid #1 – Raynor Lift Station Replacement

The Engineer's recommendation is to award this bid to Fischer Excavating, Inc., Freeport, Illinois for their base bid of \$580,527.81 and the Alternate Bid #1 of \$317,309.69, for a total project cost of \$897,837.50.

B. Ord. - Vacate Alley - Phillip MacRunnels

Mr. MacRunnels is petitioning to vacate the alley behind 1712 Factory Street. A garage and other buildings on his property are in poor condition and need to be removed; therefore, this would allow him to do the removal and build a bigger garage.

C. Authorize Execution of City Hall Imps. Projects Eng. Agreement – City/WHA

Willett, Hofmann & Associates to provide engineering services for 2 City Hall projects. Contract #1 for exterior improvements to include replacement of brick and steel lintels, general brick repairs, tuck pointing, brick cleaning and sealing. Contract #2 for interior improvements on the 2nd Floor to include painting of existing ceiling grid, removal of existing wall and floor coverings, installation of new wall and floor coverings, and removal and replacement of existing toilet fixtures.
