A. Ord. – Annexing Certain Territory to the City of Dixon, Lee County, Illinois (655 Palmyra Road)

The purpose of this Ordinance is to annex property owned by Chad Dambman located at 655 Palmyra Road.

B. Ord. – 2015 Tax Levy

This Ordinance to be passed represents the approval of the 2015 Tax Levy for \$3,955,000.
