WORK SESSION

City Manager Langloss presented on the COVID-19 Pandemic new protocols/procedures from the Governor's orders. Discussion ensued. Councilman Venier left the meeting at 1:36pm and returned at 1:37pm. Mayor Arellano was disconnected at 1:46pm and reconnected at 1:47pm. Discussions included outdoor seating on private property and public property, requirements, hours of operation, and processes to follow.
