Requested \$100,000 from the City strictly for events. Discussion ensued throughout.

Dave Hellmich from Sauk Valley Community College introduced the Impact Program and gave a recap on the program. Chris Pilling from SVCC explained the program, the pillars of the program, what can be accomplished. Requested \$150,000 commitment endowment from the City. Discussion ensued.

Chris Hammitt, Business Manager of the Dixon Municipal Band presented a recap of the last year's season, fundraising, guest artists, and band members. They would like to raise \$15,000. Requested \$25,000 from the City. Discussion ensued throughout.

Philip Atilano from the Next Picture Show presented a background and business plans for the future, programs, partnerships, events, partnerships with the Dixon Theatre and SVCC, building upgrades done and potential upgrades, and possible employees. Requested \$35,000 for general operating support. Discussion ensued.
