#### APPROVAL OF TOTAL LABOR & OUTSIDE CLAIMS

# AUTHORIZE EXECUTION OF AMENDMENT #1 TO AGREEMENT FOR COLLECTION AND DISPOSAL OF RESIDENTIAL SOLID WASTE, RECYCLABLE MATERIALS AND YARD WASTE

Commissioner Brechon moved that the Mayor be authorized to execute the Amendment #1 to the Agreement for Collection and Disposal of Residential Solid Waste, Recyclable Materials and Yard Waste. He stated this should have been discussed prior to the Council granting the hauler an extension and the City not being entitled to a credit we are getting. Mayor Burke stated this amendment is to reduce the amount of the performance bond. Attorney Branson added the bond is in place for non-performance by the refuse company. He also stated the company will be hauling 26.5 tons of sludge. Attorney Branson lastly advised that the question for the Council is when the next agreement is done does the City want to take the performance bond back up to the original amount. Dean showed how widening sidewalks by using brick borders, changing signage, stop sign postings and directory kiosks are all a part of the design study. He further showed how adding benches, granite historic plaques and street name tiles imbedded in the sidewalks help improve the community.
