Acting Mayor Blackburn advised Mayor Burke is out-of-town. He then acknowledged the Dixon Police Department, Lee County Sheriff's Department, Ogle County Sheriff's Department and the Illinois State Police for their efforts during Senator Santorum's visit to Dixon this morning. He commended all in the coordination of this event, including the Dixon City personnel in the Street, Traffic Maintenance, Water and Fire Departments.
