# APPROVAL OF TOTAL LABOR & OUTSIDE CLAIMS

Commissioner Bridgeman moved that the City of Dixon's Total Labor & Outside Claims in the amount of \$325,061.79 be approved and ordered paid. Voting Yea: Commissioners Contreras, Kelly, Blackburn, Bridgeman and Mayor Burke. Voting Nay: None. Motion carried.

#### **COUNCIL REPORTS**

Mayor Burke explained there would be a Riverfront groundbreaking ceremony on August 1 from 10:30 a.m. to noon. He added there will be exhibits, speakers and displays and the invitations will be going out soon.

Commissioner Bridgeman joked that the Council should take it easy on the Deputy Clerk tonight filling in for the City Clerk.

#### **BOARDS & COMMISSIONS REPORTS**

Mayor Burke reported the Treasurer's Report of June, 2008 and the Library Board Minutes and Treasurer's Report of June 9, 2008 were on file with the Clerk and available for inspection.

#### **VISITORS**

Josh Albrecht, Dixon Main Street, gave a detailed update for the Main Street projects currently underway, and advised on the number of active volunteers. Josh also spoke regarding the banner project and showed designs and stated the goal is 100 for this year.

# ORD. #2703 – APPROVING AMENDMENT TO DIXON CENTRAL BUSINESS DISTRICT TAX INCREMENT REDEVELOPMENT PROJECT AND PLAN

Commissioner Blackburn moved that an Ordinance approving the amendment to the Dixon Central Business District Tax Increment Redevelopment Project and Plan be passed. Discussion followed. Commissioner Blackburn read a prepared statement advising that his vote in favor tonight is due primarily to the ability to fund Riverfront TIF projects until funds generated in same TIF are able to meet obligations which will benefit both TIF districts and the City as well. He further advised his vote should not be construed as a blanket endorsement of any and all public improvements that are proposed for the Central Business District TIF. #### ORD. #2706 - SPECIAL USE - 706 PALMYRA STREET

#### AUTHORIZE EXECUTION OF ENGINEERING AGREEMENT CITY/WHA – ARTESIAN/RIVER STREET SANITARY SEWER AND ROADWAY REPLACEMENT PROJECT

Commissioner Blackburn moved that the Mayor be authorized to execute the engineering agreement between the City of Dixon and Willett, Hoffman & Associates for the sanitary sewer and roadway replacement on Artesian Place and River Street. Voting Yea: Commissioners Contreras, Kelly, Blackburn, Bridgeman and Mayor Burke. Voting Nay: None. Motion carried.

#### DISCUSSION FERAL CATS IN DIXON

Commissioner Blackburn read the letter to the Council from City Attorney Tom Sanders, which outlines the remedies for this problem. He advised other communities were investigated for this problem and he feels it will be difficult to enforce. Commissioner Blackburn advised he would like an ordinance passed similar to the City of Woodale's. Commissioner Bridgeman added these cats carry disease and kill nesting birds. He advised he does not see any other alternative other than euthinization. Mayor Burke questioned if this was the responsibility of the dogcatcher. Commissioner Bridgeman added that this could be a no-win situation as the decision on how to report these cat problems would also be an issue.
